## *GRAND SOVEREIGN'S MESSAGE*

The 142<sup>nd</sup> Annual Assembly of the United Grand Imperial Council scheduled for June 12<sup>th</sup>, 13<sup>th</sup>, & 14<sup>th</sup>, 2014 will be held in Fairborn, Ohio. The Dayton International Airport is nearby and we are only minutes from I-75 & I-70, the crossroads of America. Our committees are making final plans so your visit will be such that you will return home with great memories. We have some wonderful things to show you in Dayton, the home of aviation and many great inventions. I'm personally looking forward to seeing many of you whom my lady Lynn and I have met in our travels across the United States of America. ## *AD 313: The Time of Tolerance*

Past Sovereign Eboracum Conclave - Catania, Italy

The fourth century AD was marked by a strong, undeniable dynamism which supported innovative drive. It was the era of transition to a new religious, political and social reality. The last persecutions of Christians, the failure of the Roman Tetrarchy, Constantine's victory at the Milvian Bridge under the sign of Christ, the meeting between Constantine and Licinius in which the Christian Religion was confirmed as lawful, characterized a society still divided between paganism and Christianity and was the maker of great political and religious change. It was the age of ideological upheaval caused by the political ideology of Constantine the Great.

The historical sources which celebrate the milestones of the military and political career of Constantine are mainly: "*De mortibus persecutorum*" (*On the Death of the Persecutors*) of Lactantius, and "*The Life of Constantine*" and "*Ecclesiastical History*" of Eusebius, Bishop of Caesarea. These accounts, unfortunately, function to represent the emperor as an instrument of divine providence, and outline a highly idealized portrait of the king as a servant of God and his image on earth, equipped with all the highest virtues indispensable to carry out its mandate.

Quite apart from the overtly laudatory, the sources, however, also report evidence of concrete steps by which Constantine became the first guarantor of religious freedom and at a later date, the promoter of the institutionalization of the new religion. Among the first came the provisions by which it put an end to the persecution of Christians and he allowed the citizens of the Roman empire complete freedom of worship.

This year marks the seventeenth centennial of the proclamation of religious tolerance, a problem still topical which, long before the declaration of human rights, the Empire undertook to respect the conscience of every human being.

The Roman Catholic tradition has related the restoration of religious peace with a formal act: the Edict of Milan, or Edict of Tolerance of February AD 313, which would have ushered in a revolution in politics and religion. From time immemorial this edict has been subject to various evaluations by researchers, who often stood on different sides of the issue. So much so that today, when referring to the Edict of Milan one generally adds, the preface 'so called' because there is no unequivocal proof of the existence of this document.

In 313 the political setting of the Roman Empire was ruled by two personages both elevated to the dignity of Augustus: Constantine the Western Emperor and Licinius the Eastern Emperor.

What is certain is that Constantine and Licinius met in Milan in February 313 for the marriage of the latter with Constantia, half-sister of Constantine. On this occasion, the two Emperors discussed the question of religious policy. On the question of Christianity the decisions taken in Milan by the two emperors had to be relatively simple: they agreed that Christians throughout the Empire should enjoy the freedom of worship and obtain restitution of property confiscated in the course of previous persecution.



The Lactantius testimony and Eusebius versions in this regard are fundamentally the same. Lactantius cites the Latin text of a disposition of Licinius for enforcement of the resolution adopted during the Milanese reunion, while Eusebius cites the Greeks' version of such imperial disposition. Both the Latin document and the Greek clearly state that the measure reproduces the decisions taken jointly.

The agreement of Milan did not translate into any formal act. The existence of an edict had been assumed by a passage of Eusebius, according to which after the defeat of Maxentius, Constantine and Licinius would have enacted a "most perfect law" in favor of Christians.

Even today, while the historical vulgate continues to refer to an "Edict of Milan", many scholars consider its existence unlikely. By 1891 the German historian Otto Seeck with his publication of the book "*Das sogenannte Edikt von Mailand*" had demonstrated its non-existence with incontrovertible arguments. The misinterpretation, to a large extent, derives from the misleading assignation of the term "edict" to a document of bureaucratic provisions sent to the functionaries of the Empire. So, into Constantine's biography and into legend, a directive was transformed in a solemn declaration of intent to become the best known example of that upheaval that will assure the rise of Christianity in the Empire and lead to the development of modern Christian identity.

On the other hand, the most complete text which discusses the "Edict of Milan", namely that of Lactantius, expressly refers to a message sent to the governor of Bithynia, where the edict of Galerius (AD 311) was applied to a very limited extent. The text of the message closed with the recommendation of its dissemination through public posting, but this is just a recommendation that made binding the imperial directive.

In fact, the edict, even if it is shown to be in part an historical forgery, has become over the centuries an epochal symbol, and AD 313, in many ways, the beginning of an era of radical political and social transformation that opened Christianity to the masses and set the conditions for its passage, in a few decades, from a lawful but private religion to a public and official religion, and finally, a unique religion of the Roman Empire.

He attended Catania (Sicily) public schools and the University of Catania, receiving a degree in Physics; he is a teacher of Physics. He was Raised a Master Mason in "Victoria" Lodge #806 in Catania, June 1974, and served as Master on two occasions (1981-1983 and 1996-1998). Exalted in Katana Chapter 32, Royal Arch Masons in 1978, and served as High Priest. He also served as Most Excellent Grand High Priest of Grand Chapter Royal Arch Masons of Italy from 2004-2007. In 1978, greeted in Royal & Select Master in Etna Council #15, serving as Illustrious Master. Knighted in 1978 in Amenaro Commandery #13, and served as Eminent Commander for 3 years. ## ***FIRST YORK RITE CONFERENCE OF LATIN AMERICA***

A three day York Rite Conference, the first ever, was held in Guatemala City 21 - 24 November 2013. The conference president was Jaime Perez Velez Olvera, and the Conference Coordinator was Humberto Alfredo Antono Juarez Navas (Ambassador of the International General Grand Chapter of the Royal Arch), assisted by Alejandro Larrave, High Priest of Royal Arch Chapter No.1 in Guatemala. In attendance were 60 York Rite Masons, including Edmund T. Harrison, General Grand High Priest of the Grand Chapter Royal Arch International; Dave Grindle, Grand Secretary General of the Council of Cryptic Masons; Sir Dave Goodwin, Grand Master Knights Templar; and, Thomas Jackson, Executive Secretary of the Confederation of Regular Grand Lodges of the World. In addition, many officials of the Grand Chapters and Grand Masters of Latin America were present.

Freemasonry in Latin America is growing at a great rate, particularly York Rite Masonry. The purpose of this Conference was to bring the leaders of this vast geographic area together, and develop a plan to organize future growth. To this end, the first order of business was to discuss and establish the Grand Chapter of Central America, consisting of Guatemala, Costa Rica, El Salvador and Honduras. This was accomplished with all leaders in agreement.

The second major undertaking was to establish viable geographic regions within Latin America. Several recommendations were discussed, and in the end, three regions were established: In the North, Mexico and the Grand Chapter of Central America; In lower Central America and Northern South America, Panama, Brazil, Paraguay, Venezuela, Columbia, Ecuador and the Caribbean area; and finally, in the South, the remaining South American countries. Appropriate officials will be appointed to regulate these geographic regions. It is anticipated that a Deputy Grand High Priest will be appointed for each region, who will report directly to the General Grand High Priest.

In addition to these important decisions, there were many presentations to update conference attendees on various aspects of the York Rite and its growth in Latin America.

The Conference was conducted throughout in Peace, Harmony and Brotherly Love! Old friendships were renewed and new friendships created, that will only strengthen our Fraternity as we grow in the future.

## ***A BIT OF HISTORY* (continued from the October 2013 Byzantium)**

The Red Cross of Constantine in America began its march of recorded history in 1869 when the Earl of Bective, at that time Lord Kenlis, Grand Sovereign of the Grand Imperial Conclave of England, appointed Colonel W. J. B. MacLeod Moore, then the Grand Prior of Masonic Knights Templar of Canada, as the Chief Inspector General of the Order of Red Cross of Constantine for the Dominion of Canada. On February 16, 1870, the Sovereign Grand Conclave of England Authorized Illustrious Sir W. J. B. MacLeod Moore of La Prairie Canada, to introduce the Order into the United States.

Under this commission of the Grand Imperial Conclave of England, several Conclaves were organized, among them the Grand Imperial Council of Illinois on August 30, 1872, with Sir Jonathan J. French as Most Illustrious Grand Sovereign. Thus, only 2 months and 16 days separated the institution of what in later years was to become known as the Empire of the East and the Empire of the United States, Mexico and the Philippines, or the Empire of the West. From June 14, 1872 to May 29, 1875, a total of ten Grand Imperial Councils were chartered in Pennsylvania, Illinois, New York, Massachusetts, Michigan, Kentucky, Indiana, Vermont, Maine and New Jersey.

On June 1, 1875, representatives of these Grand Councils met in the Masonic Temple in New York City, and established a Sovereign Grand Council of the United States with Albert G. Goodall of New York as Most Illustrious Grand Sovereign. The Council had limited jurisdiction of the State Grand Councils. Specifics of the Grand Council were outlined in a document that listed powers of the Council and limitations of the Council. A fee for membership was established as to be “not less than \$10.00” and the stipulation placed upon membership that no one would be admitted who “is not a Royal Arch Mason in good standing.”

The links of brotherhood with England remained strong. Through the influence of Sir Knight Alfred Creigh, a treaty was signed on March 10, 1877, wherein the Sovereign Grand Council of the United States of America made and entered into a solemn and binding obligation with the Grand Imperial Council, Knights of the Red Cross of Constantine, and Appendant Orders for England, Wales and the British Dependencies. The Treaty acknowledged the power and authority of the Mother Council of England, united into one Grand Body all Grand and Subordinate Bodies in the United States, pledged Masonic faith that the “landmarks” as preserved in England and the work of the ritual should be preserved intact in every respect and to preserve a perpetual friendship, based upon Christian principles, representatives were to be appointed that fraternal intercourse “may be preserved forever.” This Treaty remained until March 6, 1894, when the Grand Imperial Council at Pennsylvania withdrew from the Sovereign Council. And, on January 30, 1895, the Grand Imperial Council of Illinois also withdrew from the Sovereign Council. Charles E. Chalmes, Past Grand Sovereign of the Grand Imperial Council of Pennsylvania, in a 1935 written history stated that the Order had attracted the outstanding leaders of the Craft in the various states establishing Grand Councils. When the responsible and powerful leaders banded together in a new organization, one can appreciate their personal ambition to dominate this country-wide Order, which had always been most exclusive.

In response to Pennsylvania and Illinois decisions, the Grand Sovereign of the Sovereign Grand Council, issued a proclamation that all Conclaves and Knights of the Red Cross of Constantine were warned and commanded not to communicate with either of these two Grand Councils. The edict was without teeth or meaning and the Sovereign Grand Council of the United States thereafter gradually ceased to function and disintegrated. The ambitions of prominent Masonic leaders to form a nation-wide Grand Jurisdiction with absolute power met with failure.
